

**PROTOCOL**  
**OF THE JOINT COMMITTEE FOR SCIENTIFIC AND**  
**TECHNOLOGICAL CO-OPERATION**  
**BETWEEN THE REPUBLIC OF CROATIA AND HUNGARY**

**held by correspondence in December 2018**

In accordance with Article 9 of the Agreement between the Government of Hungary and the Government of the Republic of Croatia on Scientific and Technological Co-operation, signed on January 25, 2002, in Zagreb, the Ministry of Science and Education of the Republic of Croatia and the National Research, Development and Innovation Office of Hungary (hereinafter referred to as "the Parties") established the Joint Committee for Scientific and Technological Co-operation (hereinafter referred to as "the Joint Committee"), in order to implement the above mentioned Agreement.

The Agreement is implemented by the Ministry of Science and Education in Croatia and the National Research, Development and Innovation Office in Hungary.

**1. Review of project proposals of Croatian and Hungarian research institutions for the period 2019 – 2020**

**1.1. Selection of projects**

The Croatian executive agency responsible for the overall management of this Protocol, the Ministry of Science and Education has received **11** project proposals. After the eligibility check **10** projects were accepted and sent for evaluation.

The Hungarian executive agency being responsible for the overall management of this Protocol, the National Research, Development and Innovation Office has received **11** project proposals. After the eligibility check **9** projects were accepted and sent for evaluation.

Both Parties ranked the project proposals according to their internal procedures of review. On the basis of the scientific merits of the proposals, as measured by a peer review, and the mutual interest of the Parties, the Joint Committee decided to support **7** projects listed in *Annex 1*.

**1.2. Financial conditions**

The executive agencies responsible for the overall management of this Protocol will cover the costs of the exchange of scientists as follows:

**CROATIAN SIDE:**

The Croatian Side will fund the travel costs of Croatian researchers and provide 100 EUR daily allowance or 1.000 EUR monthly allowance for their scientists.

## HUNGARIAN SIDE:

The Hungarian Side will fund the travel costs of Hungarian researchers and provide 30.000 HUF daily allowance or 300.000 HUF monthly allowance for their scientists.

### **1.3. Administrative conditions**

At the end of each year a report on the progress made during the year shall be submitted to the executive agencies responsible for the overall management of this Protocol.

At the end of the project a final report on the results achieved shall be submitted to the executive agencies responsible for the overall management of this Protocol.

The reports might be evaluated by the Joint Committee in its forthcoming session.

## **2. Preparation of the next Call for Proposals for the period 2021 – 2022**

### **2.1. Priority Fields of Co-operation**

The Joint Committee identified the following fields as areas of priority for the next phase of co-operation:

- Life sciences
- Agricultural sciences, biotechnology
- Environmental sciences
- Energy saving technologies
- Information technologies, engineering, automation

Priority will also be given to those project proposals that envisage a broader co-operation in the framework of EU Framework Programmes (Horizon2020) and other European initiatives (such as EUREKA, COST).

### **2.2. Procedure for the selection of projects to be supported for 2021-2022**

The executive agencies responsible for the overall management of this Protocol will publish the call for proposals at least eight months prior to the forthcoming session of the Joint Committee.

Research projects will be developed jointly by researchers from scientific institutions in the two countries. The researchers will then submit these proposals to the respective executive agencies responsible for the overall management of this Protocol. The deadline for submission will be at least one month after the publication of the call for proposals; the exact date will be agreed by the executive agencies.

The executive agencies responsible for the overall management of this Protocol will exchange the lists containing the basic data of the project proposals submitted to them. The executive agencies will review and assess the project proposals according to their internal procedures. The Joint Committee will select the projects to be funded during its forthcoming session.

The stipulations of this Protocol shall come into force upon its signing and shall prevail until the signing of the next Protocol.
